**APPROVAL OF COMMUNITY SERVICES BLOCK GRANT (CSBG)
COMMUNITY ACTION CONTRACT FOR THE 2012 CSBG PROGRAM YEAR**

WHEREAS, the Iowa Department of Human Rights/Division of Community Action Agencies has forwarded Contract No. CSBG-12-07, on file with the City Clerk as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, Contract No. CSBG-12-07, by and between the Iowa Department of Human Rights/Division of Community Action Agencies and the City of Des Moines, allocates \$570,849 to the City of Des Moines for the provision of community services to low-income persons during the period from October 1, 2011 through December 31, 2012; and

WHEREAS, approval of Contract No. CSBG-12-07 is in the best interest of the City as it will provide for a variety of services for low-income residents of Des Moines.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that Contract No. CSBG-12-07, with a total contract budget of \$570,849 is hereby approved.


