**SET HEARING FOR CONVEYANCE OF CITY-OWNED PROPERTY
ADJOINING 700 LOCUST STREET TO 0906116 BC LTD. FOR \$5,000**

WHEREAS, 0906116 BC Ltd. is the owner of property abutting said City-owned property at the northwest corner of 700 Locust Street, and has offered to the City of Des Moines the purchase price of \$5,000.00 for the purchase of such City-owned property more specifically described below, subject to reservation of a permanent easement for public pedestrianway usage, which price reflects the fair market value of the property as currently estimated by the City's Real Estate Division; and
