The public hearing on the Amendment to the City's annual budget for the current fiscal year ending June 30, 2012 is hereby fixed and set for the 27th day of February, 2012 at 5:00 o'clock P.M. in the Council Chambers in City Hall, Des Moines, Iowa, at which time any resident or taxpayer of the City may be heard for or against the proposed budget amendment and change.
