WHEREAS, the Police Department requested the Finance Department Procurement Division to solicit bids for an agreement to furnish impounded vehicle towing and storage services for District 1 (West side) and District 2 (East side); and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V10-027 to ten (10) potential bidders with four (4) bids received; and

WHEREAS, the low dollar compliant bid for District 1 and District 2 was received from G & S Service Inc., 4100 E 16th Street, Des Moines, IA 50313 (Glen Mikel/Owner); and

WHEREAS, Roll Call # 09-2066, dated November 9, 2009 approved the award to G & S Service Inc. and authorized the Procurement Administrator to enter into a thirty-six month agreement, plus renewals for two (2) additional twelve (12) month periods at an annual estimated cost of \$326,632.00; and

WHEREAS, original bid specifications allow for the contractor (G & S Service Inc.) to request a fee increase after the first two (2) years of the contract term and for each year that follows to include the two (2) one year renewals; and

WHEREAS, the first two (2) years of the contract term ended December 26, 2011, and the contractor has since requested a fee increase of 3.6% which equals the current Federal Cost of Living Adjustment, and the Police Department has accepted and agrees to the fee increase request; and

WHEREAS, funding is available from POL040400/Property Management; and

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the City Council hereby accepts and approves the fee increase of 3.6% for impounded vehicle towing and storage services for District 1 and District 2 by G & S Service Inc., and further authorizes and directs the Procurement Administrator to execute an amendment to the agreement providing for such increase effective February 14, 2012.

BE IT FURTHER RESOLVED, that the Procurement Administrator is authorized to execute renewal addendums for two (2) additional twelve (12) month periods if necessary and as recommended by the Police Department, with price increases complying with the agreement terms.
