## HOLD HEARING FOR VACATION AND CONVEYANCE OF A PORTION OF EAST HARTFORD AVENUE RIGHT-OF-WAY ADJOINING 1938 SE $6^{\rm TH}$ STREET TO NEIGHBORHOOD DEVELOPMENT CORPORATION (NDC) FOR \$3,100

WHEREAS, on January 9, 2012, by Roll Call No. 12-0028, the City Council received the recommendation from the Plan and Zoning Commission that an irregularly shaped segment of East Hartford Avenue right-of-way adjoining the real property locally known as 1938 SE 6<sup>th</sup> Street, hereinafter more fully described, be vacated and conveyed to Neighborhood Development Corporation (NDC), subject to reservation of easements for all public utilities in place; and

WHEREAS, NDC is the owner of 1938 SE 6<sup>th</sup> Street, and has offered to the City of Des Moines the purchase price of \$3,100 for the purchase of the City right-of-way more specifically described below for incorporation with mixed-use redevelopment of the adjoining property, subject to reservation of public utilities in place across the right-of-way, which price reflects the encumbered fair market value of the property as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and conveyed, and the City will not be inconvenienced by the vacation and conveyance of said property; and

WHEREAS, on January 23, 2012, by Roll Call No. 12-0083, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on February 13, 2012, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public right-of-way as described below are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the right-of-way proposed to be vacated and the public would not be inconvenienced by reason of the vacation of an irregularly shaped segment of East Hartford Avenue right-of-way adjoining 1938 SE 6<sup>th</sup> Street, more specifically described as follows:
