- 3. The Municipal Housing Agency's annual budget for the fiscal year ending June 30, 2012, as set forth in operating budget document on file with the City Clerk is hereby approved and adopted.
- 4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's amended budget for fiscal year ending June 30, 2012 to the Des Moines City Council for incorporation into the City's fiscal year 2012 amended budget to be certified to the State of Iowa.
