- 4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's budget for fiscal year ending June 30, 2013 to the Des Moines City Council for incorporation into the City's fiscal year 2013 budget to be certified to the State of Iowa.
