RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION FOR METRO LOFTS

Lots 4, 5, 6, 7, 8, and 9; the vacated East/West alley lying North of and adjoining Lots 5 and 8; and the vacated North/South alley lying West of and adjoining Lots 7, 8, and 9; all in Block 30, in Original Town of Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa, except that part thereof conveyed to the City of Des Moines, Iowa, by General Warranty Deed dated February 10, 2003, and filed of record in the office of the Recorder of Polk County, Iowa, on March 31, 2003, in Book 9723, at Page 86.

This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.5 of the Agreement.
- 2. The City Clerk is hereby directed to cause a certified copy of the resolution and roll call to be recorded in the land records of the Polk County Recorder.
