APPROVING CONTRACT BETWEEN CITY OF DES MOINES AND ANIMAL RESCUE LEAGUE OF IOWA, INC. FOR LEASE OF ANIMAL SHELTER, ANIMAL SHELTER SERVICES AND CITY ANIMAL CONTROL SERVICES

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that upon passage of Municipal Code Amendments to sections 18-17 and 18-18 and the fee schedule amendment concerning fees charged at the animal shelter, the City Manager is authorized to sign, with the City Clerk to attest to the Manager's signature, the two-year contract with the Animal Rescue League of Iowa, Inc., 5452 N.E. 22nd Street, Des Moines, IA 50313, Carol Griglione, President, and the City Manager and Chief of Police or designee are authorized to carry out the terms and conditions of the contract.
