PUBLIC HEARING ON ASSESSMENT OF A \$1,500.00 PENALTY AND A 30-DAY SUSPENSION OF LIQUOR LICENSE TO THE DANLEE CORP d/b/a PHILLIPS 66 (JIFFY) LOCATED AT 3718 SW 9TH FOR VIOLATION OF IOWA ALCOHOLIC BEVERAGE LAWS

WHEREAS, an employee of Phillips 66 (Jiffy) located at 3718 SW 9th Street sold an alcoholic beverage to a person under legal age at the place of business in violation of Des Moines Municipal Code Section 10-6(9) on 12/20/11, and was convicted of the charge by a guilty plea; and

WHEREAS, Iowa Code Section 123.39 permits a local authority (city council) to suspend, revoke, or impose a civil penalty upon license/permit holders who violate the alcoholic beverage laws; and

WHEREAS, Iowa Administrative Rule 185-4.8 (123) provides that violations of the alcoholic beverage laws by any employee, agent, or servant of a license or permit holder shall be deemed the act of the licensee or permittee and subject the license or permit holder to civil penalty, suspension or revocation; and

WHEREAS, the violation of Municipal Code section 10-6(9) is the second violation for selling to a person under legal age within 2 years; An employee of Phillips 66 (Jiffy) at 3718 SW 9th Street was previously convicted of violating Iowa Code section 123.49(2)(h) by selling an alcoholic beverage to a person under legal age which offense occurred on 2/17/11; and

WHEREAS, Iowa Code Section 123.50(3) and Des Moines Municipal Code section 10-13(C)(2) provide that for a second conviction of a sale to a person under legal age under either Iowa Code section 123.49(2)(h) or Des Moines Municipal Code section 10-6(9) in a two-year period a civil penalty in the amount of \$1,500.00 and a thirty (30) day suspension of license/permit shall be imposed; and

WHEREAS, Iowa law provides that the local authority shall retain the civil penalties where the proceeding to impose the penalty is conducted by the local authority;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that:

- 1. Phillips 66 (Jiffy) located at 3718 SW9th Street is assessed a \$1,500.00 civil penalty and a thirty (30) day suspension of its Permit No. BC0021303 for sale of alcoholic beverages to a person under legal age for a second time in a two-year period.
- 2. The suspension will commence at 6:00 a.m. Monday April 30, 2012 and end at 6:00 a.m. Wednesday May 30, 2012.
- 3. The City Clerk is directed to notify the permit holder by sending through ordinary mail a copy of this resolution as soon as possible.
- 4. Phillips 66 (Jiffy) shall pay the \$1,500.00 civil penalty to the City of Des Moines at the City Clerk's Office.
- 5. This City Council action may be appealed within thirty (30) days to the Alcoholic Beverages Division of the Iowa Department of Commerce. 1918 S.E. Hulsizer, Ankeny, Iowa 50021.
