CONTINUANCE OF HEARING FOR VACATION AND CONVEYANCE OF A SEGMENT OF LINDEN STREET WEST OF 14TH STREET TO WELLMARK HOLDINGS, INC. IN EXCHANGE FOR A PERMANENT EASEMENT FOR STREET RIGHT-OF-WAY CONNECTING THE EAST TERMINUS OF THE REMAINING LINDEN STREET TO INGERSOLL AVENUE

WHEREAS, on February 13, 2012, by Roll Call No. 12-0183, the City Council received a recommendation from the City Plan and Zoning Commission that a segment of Linden Street west of 14th Street ("City Right-of-Way"), hereinafter more fully described, be vacated as requested by Wellmark Holdings, Inc. to allow for redevelopment of the eastern portion of the block for a passive recreation space with a pedestrian path circuit, subject to conditions; and

WHEREAS, Wellmark Holdings, Inc. is the owner of the real property that abuts the City Right-of-way and has requested the vacation and conveyance of such Right-of-way for the purpose of incorporation with surrounding properties for redevelopment as described above, in exchange and as consideration for conveyance by Wellmark Holdings, Inc. to the City of Des Moines of a permanent easement for street right-of-way across a comparable parcel of land from the east terminus of the remaining Linden Street right-of-way to Ingersoll Avenue ("Easement Area"); and

WHEREAS, on February 27, 2012, by Roll Call No. 12-0281, City Council set forth its proposal relating to the land exchange between Wellmark Holdings Inc. and the City, and it was further duly resolved by the City Council that the proposed vacation and conveyance of such City Right-of-Way pursuant to land exchange agreement be set down for hearing on March 12, 2012, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way by land exchange was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, on March 12, 2012, by Roll Call No. 12-0422, the hearing on said proposal was continued to March 26, 2012; and

WHEREAS, in order to complete negotiations relating to the land exchange agreement with Wellmark Holdings, Inc., a continuance of the public hearing on said proposal until the Council meeting on April 9, 2012, has been requested.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the public hearing for vacation and conveyance of a segment of Linden Street west of 14th Street to Wellmark Holdings, Inc., in exchange for a permanent easement for street right-of-way connecting the east terminus of the remaining Linden Street right-of-way to Ingersoll Avenue, be and is hereby continued to April 9, 2012, at 5:00 p.m. in the City Council Chambers.
