## SET HEARING FOR CONVEYANCE OF PROPERTY LOCATED AT 1202, 1204 AND 1300 SCOTT AVENUE TO MIDWEST AUTOMATIC FIRE SPRINKLER COMPANY FOR \$605,000

WHEREAS, the City of Des Moines must acquire the current real property of Midwest Automatic Fire Sprinkler Company, locally known as 1823 Raccoon Street, Des Moines, for the Southeast Connector Project, which acquisition requires full relocation of the Midwest Automatic Fire Sprinkler Company business; and

WHEREAS, the City of Des Moines owns excess real property that is locally known as 1202, 1204, and 1300 Scott Avenue, more particularly described below ("Property"), which building is currently being used for storage and office administration by the Des Moines Fire Department; and

WHEREAS, Midwest Automatic Fire Sprinkler Company ("buyer") has offered to the City of Des Moines the purchase price of \$605,000.00 for the purchase of such Property in order to relocate its business, which price reflects the fair market value of the Property as currently estimated by the City's Real Estate Division; and

WHEREAS, said proposed offer is being negotiated subject to the stipulations that closing will occur simultaneously with closing on the City's acquisition of 1823 Raccoon Street, and after the Fire Department has moved into the Fire Department Training and Logistics Facility; that the buyer will have access to the Property prior to closing for design and layout purposes; that the City will reimburse the buyer for costs of environmental analysis and asbestos study of the Property; that the City will remove the residential improvements located at 1204 Scott Street and install a stormwater drain system on the west side of the Property prior to closing, which drain system shall become the responsibility of buyer upon closing; and that the buyer may retain the granular surface of the truck entrance at 1300 Scott Street unless future changes to use, occupancy, or improvements upon the Property require site plan compliance; and

WHEREAS, the City of Des Moines has no current or anticipated public need for the Property and the City will not be inconvenienced by the sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City of Des Moines, Iowa proposes to convey the following described Property to Midwest Automatic Fire Sprinkler Company for \$605,000.00:
