APPROVING EXECUTION OF HOME CONTRACTS FOR \$150,000 WITH DES MOINES GREYSTONE HOMES, L.P. FOR THE CONSTRUCTION OF 26 UNITS OF SINGLE FAMILY HOUSING AT SCATTERED SITES, APPROVING THRIVENT CONSTRUCTION LOAN FOR \$150,000 FOR SIX UNITS IN THE 1400 BLOCK OF MARTIN LUTHER KING JR. PARKWAY AND WAIVING ENFORCEMENT FEES ON 1140 MARTIN LUTHER KING JR. PARKWAY

WHEREAS, on February 28, 2011 by Roll Call 11-0388 the City of Des Moines, Iowa, supported a Low Income Housing Tax Credit application for the construction of scattered site family housing to be known as Des Moines Greystone Homes and authorized staff to negotiate with the Iowa Finance Authority and Des Moines Greystone Homes for HOME funding; and

WHEREAS, in May of 2011 the City of Des Moines was informed by the Iowa Finance Authority that Des Moines Greystone Homes had received an allocation of Low Income Housing Tax Credits to construct 26 units of scattered site family housing under the ROSE program (Renter to Ownership Savings Program) dependent on final approval of \$150,000 of City HOME funds; and

WHEREAS, by Roll Call 11- 0998 on June 13, 2011, the City of Des Moines committed \$150,000 of HOME funds for the new construction of Family housing on scattered sites; and

WHEREAS, the developer of Des Moines Greystone Homes, L.P. is Hatch Development Group, (Jack Hatch and Ryan Galloway, 1312 Locust Street, 50309,) an experienced tax credit developer in Des Moines; and

WHERAS, the units are to be located at the following sites legally and locally described as:
