APPROVAL OF A \$300,000 GRANT REQUEST FOR OWNER-OCCUPIED HOUSING REPAIR:

- A. APPROVAL OF GRANT APPLICATION TO THE FEDERAL HOME LOAN BANK OF DES MOINES AFFORDABLE HOUSING PROGRAM BY THE CITY OF DES MOINES/WEST BANK TO PROVIDE REHABILITATION ASSISTANCE IN LOW-INCOME OWNER-OCCUPIED HOUSING;
- B. APPROVAL OF MEMORANDA OF UNDERSTANDING WITH GREATER DES MOINES HABITAT FOR HUMANITY AND HOME OPPORTUNITIES MADE EASY (HOME) INC. FOR SUPPORTIVE SERVICES;
- C. APPROVAL OF SUB AGREEMENT WITH WEST BANK AS THE PARTNER FHLB MEMBER BANK.

WHEREAS, the Federal Home Loan Bank manages a housing fund called the Affordable Housing Program (AHP) designed to assist in the development and maintenance of affordable housing for low and moderate income households; and

WHEREAS, financial institutions that are a member of the Federal Home Loan Bank in Iowa, Minnesota, South Dakota, North Dakota and Missouri are eligible to apply for AHP funds; and

WHEREAS, West Bank is a member of the Federal Home Loan Bank of Des Moines, is interested in the preservation of affordable housing in the City of Des Moines, and has sponsored successful applications with the City of Des Moines in 2000, 2001, 2004, 2006, and 2010; and

WHEREAS, a grant application for \$300,000, attached hereto as Exhibit A, has been prepared by the City of Des Moines for submission by West Bank to the Federal Home Loan Bank of Des Moines to assist with low income owner-occupied rehabilitation; and

WHEREAS, the grant funds will be used by the City Department of Community Development to supplement Community Development Block Grant (CDBG) funds used to provide major rehabilitation and lead remediation for low-income owner-occupants; and

WHEREAS, Greater Des Moines Habitat for Humanity and Home Opportunities Made Easy (HOME), Inc. have agreed to enter into Memoranda of Understanding with the City, attached hereto as Exhibit B, by which these non-profit organizations will provide supportive services to participants in the minor rehabilitation program.

WHEREAS, West Bank has requested that the City of Des Moines approve an additional agreement that provides processes and procedures for satisfying monitoring and compliance requirements, if the grant is received; and

WHEREAS, said agreement has been developed setting the terms and conditions for the use of these funds and is on file with the City Clerk as Exhibit C.

- 1. The City's Community Development Department's Neighborhood Conservation Services Division will work in cooperation with West Bank to disperse the Affordable Housing Program Grant funds.
- 2. The form of agreement on file with the City Clerk as Attachment 1 is hereby approved and the City Legal Department is hereby authorized to approve any non-substantive changes necessary to finalize the document.
