WHEREAS, salt conveyors have been competitively bid and are available from Kimco USA, 118 E Trefz Drive, Marshall, IL 62441, Max Coffey, President, per City of Chicago Contract # 22093; and

WHEREAS, Municipal Code section 2-726 (e) authorizes the Procurement Administrator to procure from any federal, state, or local government unit or agency thereof, without conforming to the competitive bidding requirements of procurement Division, such goods and/or services as are authorized by the city manager, provided that the city manager determines and declares in writing that such goods and/or services were competitively procured by such unit or agency pursuant to competitive procurement procedures substantially equivalent to those set forth in this division, and can be procured without mark-up from such other federal, state, or local government unit or agency; and

WHEREAS, the Metro Waste Authority will purchase the salt conveyor from the City of Chicago contract, at a total cost of \$99,903.33, for the participants in the Metropolitan Salt Storage Facility, and cost will be divided in the same proportions as the salt storage agreement, with the City of Des Moines cost at \$44,956.50; and

WHEREAS, funding is available from PKS040400/Street Maintenance; and

WHEREAS, The Procurement Administrator and the Public Works Department recommends approval of the City of Chicago contract purchase;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby approves the joint purchase from the City of Chicago contract purchase of a Kimco salt conveyor from the Metro Waste Authority at a total cost of \$44,956.50.
