WAIVER OF CITY'S SPECIAL ASSESSMENTS AND CITY INSPECTION FEES TO ALLOW FOR REDEVELOPMENT OF THE PARCEL AT 1702 FOREST AVENUE

WHEREAS, the real estate at 1702 Forest Avenue, more specifically described as follows:

LOT 55 GARDEN ADDITION, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa

contains a vacant structure assessed as residential property that is a public nuisance and suitable for redevelopment for housing use; and

WHEREAS, NFC Properties, LLC has taken tax deed to the real estate and will be demolishing the existing structure and building a new structure on the site;

WHEREAS, NFC Properties, LLC is a non-profit development arm of the Neighborhood Finance Corporation, (NFC), 1912 6th Avenue, Des Moines, IA 50314, Holly Olson, Executive Director; and

WHEREAS, the parcel is encumbered with liens for substantial amounts of special assessments owed the City as itemized below; and

WHEREAS, waiving such special assessments is in the best interest of the City of Des Moines and the NFC, LLC;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines Iowa, as follows:

1. That the special assessments and fees owed to the City on the parcel at 1702 Forest Avenue, specifically itemized below are hereby dismissed and released, and the City Engineering Department and/or Community Development Department is hereby authorized and directed to correct the records at the Polk County Treasurer's Office:


