APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING PROCUREMENT OF 2300 TONS OF ROCK SALT FROM THE CITY OF WEST DES MOINES AT A TOTAL COST OF \$128,593.00

WHEREAS, Public Works Department requested the Finance Department Procurement Division to order 2300 tons of rock salt for use by the Street Maintenance Division for 2012/2013 winter storm operations; and

WHEREAS, the Central Iowa Salt Group (CISG) historically bids for rock salt in the spring of each year for multiple governmental entities in the metro area; and

WHEREAS, by Roll Call No. 09-877, dated May 18, 2009, City Council approved an award to Hutchinson Salt for 10.000 tons of rock salt at \$57.17/ton; and

WHEREAS, the City of West Des Moines purchased 2300 tons more than their storage capacity will allow following the light winter of 2011/2012, and wishes to sell said surplus salt to the City of Des Moines at the current CISG joint bid price of \$55.91 to avoid remote storage costs; and

WHEREAS, funding is available from PWK040400/Street Maintenance; and

WHEREAS, the City Manager recommends that the procurement of rock salt be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that good cause has been shown to exempt the procurement of 2300 tons of rock salt from the Procurement Ordinance competitive bidding requirements.

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of 2300 tons of rock salt from the City of West Des Moines, at a total cost of \$128,593.00.
