APPROVE AND AUTHORIZE THE MAYOR TO SIGN AMENDMENT #10 TO THE COMMUNITY DEVELOPMENT BLOCK (CDBG) DISASTER RECOVERY CONTRACT (#08-DRH-209) BETWEEN THE CITY OF DES MOINES AND THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) TO CLOSE OUT COMPLETED ACTIVITIES

WHEREAS, the Iowa Economic Development Authority (IEDA) is administering Community Development Block Grant (CDBG) Disaster Recovery Funds to assist with flood recovery per a statewide allocation plan approved by the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, IEDA and the City of Des Moines previously entered into a Contract (the "Contract") pursuant to which IEDA granted funds to the City of Des Moines to aid in recovery from the natural disasters of 2008; and

WHEREAS, Major Amendment #10 (attached as Exhibit A) adjusts the budget of the existing contract to reflect actual dollars used and performance targets reached. All money has been drawn for the activities and completed; and

WHEREAS, the budget is being adjusted from \$8,629,703 to \$8,580,910. The difference in the budgets will be recaptured by the Iowa Department of Economic Development and reallocated to other eligible activities.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Major Amendment #10 of the Community Development Block Grant Housing Disaster Recovery Fund Contract with Iowa Department of Economic Development (Contract Number 08-DHR-209), attached hereto, is approved and the Mayor is authorized to sign the amendment.
