WHEREAS, a Housing Choice Voucher Homeownership Program participant is utilizing US Bank for mortgage financing and US Bank has requested that a "Section 8 Homeownership Subsidy Program Agreement" be completed with each Housing Choice Voucher Homeownership participant and City Legal has approved the form of the agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board of the City of Des Moines, Iowa, that the Director of Housing Services Department or his/her designee is authorized to sign said Section 8 Homeownership Subsidy Program Agreement and authorization to sign the Agreement with US Bank is hereby approved.

BE IT FURTHER RESOLVED, that upon other financial institutions or mortgage lenders requesting similar housing assistance subsidy agreements, the Director of the Housing Service Department or his/her designee is also authorized to sign and execute such Housing Choice Voucher Homeownership subsidy agreements.
