APPROVING AND AUTHORIZING THE EXECUTION OF DEPARTMENT OF TRANSPORTATION CONDITIONAL AND PRELIMINARY TERM SHEET FOR THE TIGER DISCRETIONARY GRANT FOR THE SOUTHEAST CONNECTOR PROJECT BETWEEN SE 14TH STREET AND SE 30TH STREET

WHEREAS, the FY2012 Appropriations Act appropriated \$500 million to be awarded by the Department of Transportation for National Infrastructure Investments. Due to the similarity to previous appropriation for the Transportation Investment Generating Economic Recovery, or "TIGER Discretionary Grant", DOT is referring to the grants for National Infrastructure Investments under the FY 2012 Appropriations Act simply as "TIGER Discretionary Grants"; and

WHEREAS, on February 27, 2012, by Roll Call 12-0266, City Council authorized submitting an application for the TIGER Discretionary Grant for the Southeast Connector Project between SE 14th Street and SE 30th Street; and

WHEREAS, on June 22, 2012, the U.S. Transportation Secretary announced the projects selected to receive funding from the TIGER 2012 program, including \$10 million for the Southeast Connector; and

WHEREAS, the Department of Transportation has provided a Conditional and Preliminary Term Sheet for the TIGER Discretionary Grant for the Southeast Connector project between SE 14th Street and SE 30th Street; and

WHEREAS, the final TIGER Grant Agreement will be negotiated between the U.S. Department of Transportation, Federal Highway Administration and City of Des Moines following execution of this Conditional and Preliminary Term Sheet; and

WHEREAS, Conditional and Preliminary Term Sheet includes the project scope, budget and schedule for the Southeast Connector – SE 14th Street to SE 30th Street.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the Conditional and Preliminary Term Sheet between the City of Des Moines, US Department of Transportation, Federal Highway Administration and the Iowa Department of Transportation, a draft copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, subject to approval by the Office of the Secretary of Transportation.
- 2. That the Mayor is hereby authorized and directed to execute the Conditional and Preliminary Term Sheet for and on behalf of the City of Des Moines, Iowa.
