APPROVING RETENTION OF FAEGRE BAKER DANIELS TO PROVIDE ADVICE AND REPRESENTATION ON RAILROAD MATTERS FOR THE SOUTHEAST CONNECTOR PROJECT BETWEEN SE 14TH STREET AND SE 30TH STREET

WHEREAS, the FY2012 Appropriations Act appropriated \$500 million to be awarded by the Department of Transportation for National Infrastructure Investments. Due to the similarity to previous appropriation for the Transportation Investment Generating Economic Recovery, or "TIGER Discretionary Grant", DOT is referring to the grants for National Infrastructure Investments under the FY 2012 Appropriations Act simply as "TIGER Discretionary Grants"; and

WHEREAS, on February 27, 2012, by Roll Call 12-0266, City Council authorized submitting an application for the TIGER Discretionary Grant for the Southeast Connector Project between SE 14th Street and SE 30th Street; and

WHEREAS, on June 22, 2012, the U.S. Transportation Secretary announced the projects selected to receive funding from the TIGER 2012 program, including \$10 million for the Southeast Connector; and

WHEREAS, the City Council is approving a Conditional and Preliminary Term Sheet for the TIGER Discretionary Grant for the Southeast Connector project between SE 14th Street and SE 30th Street which will be the basis of the final TIGER Grant Agreement will be negotiated between the U.S. Department of Transportation, Federal Highway Administration and City of Des Moines following execution of this Conditional and Preliminary Term Sheet; and

WHEREAS, Conditional and Preliminary Term Sheet includes the project scope, budget and schedule for the Southeast Connector – SE 14th Street to SE 30th Street provides that the City is to have agreements with the Railroads by December 2012.
