**ACCEPTING COMPLETED CONSTRUCTION AND APPROVING FINAL PAYMENT  
FOR GRAND AVENUE - 19TH STREET TO POLK BOULEVARD OLDER DRIVER-  
PEDESTRIAN TRAFFIC CONTROL, IOWA SIGNAL INC.**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer, showing the cost of the construction of the Grand Avenue - 19th Street to Polk Boulevard Older Driver-Pedestrian Traffic Control, 04-2009-011, in accordance with the contract approved between Iowa Signal Inc., Wayne Lesley, President, 3711 SE Capitol Circle, Grimes, IA 50111, under Roll Call No. 10-1692, of October 11, 2010, and the City of Des Moines, and recommending the acceptance thereof, be and the same is hereby approved, and accepted; and

BE IT FURTHER RESOLVED: That \$156,371.31 is the total construction cost of which \$148,552.74 has been paid to the Contractor, with a final partial payment of \$0.00 to be paid now, and the remaining balance of \$7,818.57 be paid at the end of thirty days, provided no claims or liens have been filed against said project, and provided that a release of this payment has been approved by the Iowa Department of Transportation through the Department of Engineering for the City of Des Moines, Iowa. Said Engineering Department shall not release this payment until all project audits have been completed, and any monetary penalties resulting from audit deficiencies shall be deducted from said balance of \$7,818.57 before being released to the Contractor.
