APPROVING FACILITY USE AGREEMENT FOR GRAY'S LAKE PARK, MEREDITH TRAIL, SOUTHWEST CONNECTOR TRAIL, AND SIMON ESTES AMPHITHEATER FOR 2012 HY-VEE TRIATHLON

WHEREAS, the City of Des Moines is the owner of Gray's Lake Park the Meredith Multi-Use Recreational Trail ("Trail"), and the Simon Estes Amphitheater; and

WHEREAS, Hy-Vee is hosting the 5150 Triathlon Series in the Greater Des Moines area on September 1-2, 2012 ("the 2012 Hy-Vee Triathlon"); and

WHEREAS, Hy-Vee desires to stage the Age Group (September 2) and Iron Kids (September 1) swim, bike and run events within Gray's Lake Park and to use a portion of the Meredith and Southwest Connector Trails for the run event, and to stage the Elite Cup (September 2) swim event at the Amphitheater, and to use the former railway right-of-way south of the Southwest Connector Trail for parking; and

WHEREAS, staff from the City Manager's Office and the Park and Recreation Department have negotiated a Facility Use Agreement with Hy-Vee to allow use of the above described City park and recreational facilities to allow Hy-Vee to stage the 2012 Hy-Vee Triathlon, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the City Council recognizes that such use of the above described facilities will be beneficial to the citizens of the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Facility Use Agreement, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to execute such Agreement on behalf of the City and City Clerk is directed to attest to his signature
