APPROVAL OF PIPELINE CROSSING AGREEMENT WITH THE UNION PACIFIC RAILROAD COMPANY FOR THE 2012 SEWER REPAIR – CONTRACT 2

WHEREAS, the Union Pacific Railroad Company owns an abandoned railroad property near the intersection of S.E. 1st Street & Van Buren Avenue; and

WHEREAS, in connection with the 2012 Sewer Repair – Contract 2, the City has proposed to install a new sewer across the abandoned Union Pacific Railroad property; and

WHEREAS, the City and Union Pacific Railroad Company have negotiated the terms of a Pipeline Crossing Agreement to allow for the installation of the above-referenced storm sewer improvements within the railroad right-of-way for the project, with license fee to be paid by the City to Union Pacific Railroad Company of a total amount of \$2,000.00.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, that the Pipeline Crossing Agreement with the Union Pacific Railroad Company in connection with the 2012 Sewer Repair – Contract 2 Project, a copy of which is now on file in the office of the City Clerk, be and is hereby approved; the Mayor and City Clerk are hereby authorized and directed to execute said Agreement for and on behalf of the City of Des Moines, Iowa; the Engineering Department is hereby authorized to administer the terms of said Agreement; and the Finance Director is authorized to make payment to the railroad for the license fee.
