**APPROVING INITIAL LIHEAP (LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM)  
CONTRACT WITH THE IOWA DEPARTMENT OF HUMAN RIGHTS, DIVISION OF  
COMMUNITY ACTION AGENCIES FOR ENERGY-RELATED ASSISTANCE FOR LOW-INCOME  
PERSONS FROM OCTOBER 1, 2012 TO SEPTEMBER 30, 2013**

WHEREAS, Des Moines Community Action Agency, Housing Services Department, is charged with administering the Low-Income Home Energy Assistance Program (LIHEAP); and

WHEREAS, the Iowa Department of Human Rights, Division of Community Action Agencies has now forwarded Contract No. LIHEAP-13-07 on file with the City Clerk as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, Contract No. LIHEAP-13-07, by and between the Iowa Department of Human Rights, Division of Community Action Agencies, and the City of Des Moines, allocates \$154,686 to the City of Des Moines for the provision of energy-related assistance to low income persons during the period from October 1, 2012 through September 30, 2013; and

WHEREAS, approval of Contract No. LIHEAP-13-07 is in the best interest of the City as it will provide for the increase in energy-related assistance available for low-income residents of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that Contract No. LIHEAP-13-07, with a total contract budget of \$154,686, is hereby approved.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized and directed to execute the above-referenced contract and the City Clerk to attest to his signature.

BE IT FURTHER RESOLVED that the City Manager is authorized and directed to execute any changes in the terms, conditions, or amounts specified in this contract and the Housing Services Director or his designee is designated to sign all fiscal and program forms required by this contract.




