APPROVING AN AMENDMENT OF A
CHAPTER 28E AGREEMENT WITH MARSHALL COUNTY AND MARSHALL COUNTY
EMERGENCY MANGEMENT COMMISSION FOR THE
PROVISION OF HAZARDOUS MATERIALS RESPONSE SERVICES

WHEREAS, the City of Des Moines has since August of 1988 provided hazardous materials response services to Polk County, and has since 1995 provided hazardous materials response services to the counties of Boone, Dallas, Madison, Marshall, Story, and Warren, and to the Marshall County Emergency Management Commission and Story County Emergency Management Commission, all pursuant to Chapter 28E Agreements executed with said governmental bodies; and

WHEREAS, pursuant to said Chapter 28E Agreements, said governmental entities have agreed to reimburse the City of Des Moines for all costs which the City incurs in the provision of hazardous materials response services and have agreed to defend and hold harmless the City of Des Moines in the provision of said services with those jurisdictions; and

WHEREAS, said 28E Agreements also required the City of Des Moines to purchase insurance or other available coverage for the purpose of providing the financial resources for the participating governmental bodies to assume such risk and liability and specified that such governmental bodies would pay for the premium or costs of the purchased coverages on an equally proportional basis and that the City would purchase \$450,000 per incident of insurance to cover the cost of occupational injury, which was equal to the City of Des Moines self-insured retention amount in 1995; and

WHEREAS, the City's current self-insured retention has increased to \$1,000,000 per incident and it is recommended by the Fire Chief and the Risk Manager that said 28E Agreements be amended to delete the \$450,000 fixed amount for occupational injury coverage and replace it with terms which provide for occupational injury coverage equal to a self-insured amount based on reasonably available coverage and a new cost allocation formula for the cost of any loss that is not insured, as described in the attached Council Communication; and

WHEREAS, city staff has negotiated an Amendment to said 28E Agreements with said governmental entities; and

WHEREAS, the Marshall County Emergency Commission has executed the Amendment to Agreement for the Provision of Hazardous Materials Response Services Between the City of Des Moines, the Marshall County Emergency Management Commission and Madison County Under Chapter 28E, a copy of which is on file in the City Clerk's Office, and the Amendment will be presented to the Marshall County Board of Supervisors for approval and execution; and

2. That the Mayor and City Clerk be and they are hereby authorized and directed to execute and attest, respectively, said Amendment for and on behalf of the City of Des Moines, Iowa, subject to execution of this Amendment by the Marshall County Board of Supervisors.
