to remove the VDL Vehicle Display Lot Overlay District from the subject property, subject to the following conditions which are agreed to and accepted by execution of an Acceptance of Rezoning Ordinance in writing by all owners of the property and is binding upon the owners and their successors, heirs and assigns as follows:

- a. Provision of 27-foot minimum paving setbacks along the Southeast 14th Street and East Lacona Avenue frontages, and 17-foot minimum paving setbacks along the south and east property lines.
- b. Provision of landscaping materials in excess of minimum requirements of the Des Moines' Landscaping Standards to be determined by the Commission at Site Plan review.
