APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR STORM SEWER IMPROVEMENTS, WOODS OF COPPER CREEK PLAT 1,
BETWEEN MCANINCH CORPORATION AND HDR LAND DEVELOPMENT, LLC

WHEREAS, on May 7, 2012 under Roll Call No. 12-0680, the City Council approved a private construction contract in the amount of \$57,653.85, between McAninch Corporation, Douglas D. McAninch, President, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and HDR Land Development, LLC, Larry Handley, Manager, 2575 North Ankeny Boulevard, Ankeny, IA, 50023 - as Owner, for construction of Storm Sewer Improvements described as storm sewer construction to serve The Woods of Copper Creek Plat 1 proposed subdivision, located between N.E. 44th Court & N.E. 51st Court north of Easton Blvd., as per Plan File Nos. 544-001/021, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$57,653.85, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and HDR Land Development, LLC, which were approved under Roll Call No. 12-0680, dated May 7, 2012, be received and filed; and that completion of said Storm Sewer Improvements described as storm sewer construction to serve The Woods of Copper Creek Plat 1 proposed subdivision, located between N.E. 44th Court & N.E. 51st Court north of Easton Blvd., as per Plan File Nos. 544-001/021, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
