RESOLUTION APPROVING APPLICATION TO THE IOWA ECONOMIC
DEVELOPMENT AUTHORITY FOR ENTERPRISE ZONE BENEFITS FOR THE
ANAWIM HOUSING, INC. LEGACY PARK HOUSING PROJECT IN THE
ENTERPRISE COMMUNITY ENTERPRISE ZONE

WHEREAS, on September 14, 1998 by Roll Call No. 98-2603, the Des Moines City Council established the Des Moines Enterprise Zone Commission (“Commission”), and on July 21, 1997 by Roll Call 97-2586 the City Council approved the Enterprise Community Enterprise Zone, all of which the State of Iowa subsequently certified, pursuant to Iowa Code Sections 15E.194 and 15E.195; and

WHEREAS, Anawim Housing, Inc., the developer, requests approval of its application for enterprise zone benefits for the rehabilitation of 33 housing units and construction of 4 housing units in the Enterprise Community Enterprise Zone involving a total investment of approximately \$4.6 million; and

WHEREAS, the Developer’s application appears to meet all of the requirements for enterprise zone benefits; and

WHEREAS, Council is requested to recommend approval of the Developer’s application for Enterprise Zone benefits to the Commission as well as the Iowa Economic Development Authority (“IEDA”), which administers the State of Iowa Enterprise Zone Tax Credits.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The application describing how the Anawim Housing, Inc. Legacy Park project meets the requirements for enterprise zone benefits, is accepted.
2. The Anawim Housing, Inc. Legacy Park application is recommended for approval to the Des Moines Enterprise Zone Commission and to IEDA.
3. The Office of Economic Development is directed to transmit a copy of this Roll Call to the Commission and to IEDA and to conduct project compliance monitoring.
4. Upon IEDA approval of the application, the Mayor is authorized to execute and the City Clerk is directed to attest to his signature on any documents necessary for the Anawim Housing, Inc. Legacy Park project to receive enterprise zone benefits.
