## RESOLUTION APPROVING APPLICATION TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY FOR ENTERPRISE ZONE BENEFITS FOR THE BROADWAY HEIGHTS L.L.C., PHASE II PROJECT IN THE NE HUBBELL-BROADWAY ENTERPRISE ZONE

WHEREAS, on September 14, 1998 by Roll Call No. 98-2603, the Des Moines City Council established the Des Moines Enterprise Zone Commission ("Commission"), and on August 29, 2009 by Roll Call 09-1560 the City Council approved the NE Hubbell-Broadway Enterprise Zone, all of which the State of Iowa subsequently certified, pursuant to Iowa Code Sections 15E.194 and 15E.195; and

WHEREAS, Broadway Heights, L.L.C., Phase II, the developer, requests approval of its application for enterprise zone benefits for the construction of 90 housing units in the NE Hubbell-Broadway Enterprise Zone involving a total investment of approximately \$8.3 million; and,

WHEREAS, the Developer's application appears to meet all of the requirements for enterprise zone benefits; and

WHEREAS, Council is requested to recommend approval of the Developer's application for Enterprise Zone benefits to the Commission as well as the Iowa Economic Development Authority ("IEDA"), which administers the State of Iowa Enterprise Zone Tax Credits.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The application describing how the Broadway Heights, L.L.C., Phase II project meets the requirements for enterprise zone benefits, is accepted.
- 2. The Broadway Heights, L.L.C. Phase II application is recommended for approval to the Des Moines Enterprise Zone Commission and to IEDA.
- 3. The Office of Economic Development is directed to transmit a copy of this Roll Call to the Commission and to IEDA and to conduct project compliance monitoring.
- 4. Upon IEDA approval of the application, the Mayor is authorized to execute and the City Clerk is directed to attest to his signature on any documents necessary for the Broadway Heights, L.L.C. Phase II project to receive enterprise zone benefits.
