WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on November 1, 2012, its members voted 11-0 in support of a motion to recommend **DENIAL** of a request from Raymond Garneau (owner) to rezone property located at 2324 Southwest 9<sup>th</sup> Street from C-1 Neighborhood Retail Commercial District to the C-2 General Retail and Highway Oriented Commercial District, to allow conversion of the existing property to a plumbing and heating shop, on the basis that the C-2 District is intended for larger retail areas where adequate buffering can be provided for adjoining residential uses. The existing C-1 District classification is a more appropriate classification given the residential nature of the area and the shallow depth of the lots fronting SW 9<sup>th</sup> Street; and

WHEREAS, on November 19, 2012 by Roll Call No.12-1766, the City Council set a public hearing on the proposed rezoning for December 3, 2012 at 5:00 p.m. in Council Chambers, City Hall, Des Moines, Iowa;
