APPROVING AND AUTHORIZING THE EXECUTION OF BURLINGTON NORTHERN SANTA FE RAILWAY GRADE CROSSING CONSTRUCTION AND MAINTENANCE AGREEMENTS AND EASEMENT AGREEMENT FOR THE SOUTHEAST CONNECTOR PROJECT

WHEREAS, the Burlington Northern Santa Fe Railway Company (BNSF) owns a railroad upon railroad tracks that proceed in a southeasterly-northwesterly direction across proposed Southeast Connector and S.E. 15th Street right-of-way; and

WHEREAS, Southeast Connector and S.E. 15th Street will require new public street crossings over said BNSF railroad tracks to be designated DOT No. 929080R and 929081X; and

WHEREAS, in connection with the Southeast Connector Project, the City has proposed to undertake a project to construct the aforementioned railroad crossings including the installation of a new crossing surface and installation of appropriate gates and signals, within BNSF's railroad right-of-way at Southeast Connector, as well as a new railroad crossing within the City street right-of-way at S.E. 15th Street; and

WHEREAS, the BNSF requires closure of existing crossings in exchange for new crossings; and

WHEREAS, Grade Crossing Construction and Maintenance Agreements (Agreements) with BNSF provide that the existing public street crossings of S.E. 8th Street and S.E. 9th Street are to be closed prior to construction of the Southeast Connector – S.E. 9th to S.E. 15th and the existing public street crossing of Scott Avenue is to be closed at the completion of the construction of the Southeast Connector – S.E. 15th Street to S.E. 30th Street; and

WHEREAS, the Agreements include a lump sum payment for future maintenance of the railroad crossing surfaces, signal equipment and signal house in the amount of \$150,000 for the Southeast Connector and \$135,000 for the S.E. 15th Street; and

WHEREAS, the Agreements further require the City to reimburse BNSF for replacement of the crossing signal equipment and signal house in the event they are damaged, destroyed or obsolete and cannot be maintained; and

WHEREAS, the Southeast Connector crossing of the BNSF requires acquisition of an easement and a temporary easement during construction for a total cost of \$52,000; and

WHEREAS, the Agreements provide for the construction and maintenance by BNSF of the above-referenced railroad crossing improvements within the railroad tracks for the Project by BNSF, with reimbursement to be paid by the City to BNSF for the actual cost of materials and labor for said improvements, as currently estimated at \$1,184,142.

NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- That the Engineering Department is directed to initiate vacation and permanent closure of Scott Avenue in the vicinity of the existing BNSF railway crossing east of S.E. 15th Street, in exchange for 6. construction and use of the new S.E. 15th Street crossing, in accordance with terms of the Agreement.
