WHEREAS, Lawra Stuart (Borrower) purchased the property locally known as 2704 E. 38<sup>th</sup> Court, Des Moines (the Property) and the Municipal Housing Agency holds a second mortgage on the property; and

WHEREAS, the Borrower has applied for forgiveness of the term of the second mortgage and staff has determined that the Borrower has successfully met all of the program requirements and qualifies for the loan forgiveness.
