COMMUNICATION PRESENTING A CONCEPTUAL ASSISTANCE PACKAGE WITH PRINCIPAL FINANCIAL GROUP FOR CAMPUSWIDE RENOVATIONS AND APPROVING SUBMITTAL OF AN IOWA ECONOMIC DEVELOPMENT AUTHORITY BUSINESS FINANCIAL ASSISTANCE APPLICATION ON BEHALF OF PRINCIPAL FINANCIAL GROUP

WHEREAS, the Principal Financial Group, represented by Larry Zimpleman, CEO, is exploring a phased renovation of its downtown Des Moines worldwide corporate headquarters campus; and,

WHEREAS, Principal currently employs approximately 13,000 people worldwide and 6,000 in Des Moines, with an increasing percentage of its workforce being "knowledge based" functions such as IT, actuarial, accounting, asset management, and legal, which require a different physical environment than the "transaction based" functions which previously dominated Principal's workforce; and,

WHEREAS, This first phase of renovations is estimated to cost \$238.5 million and will include significant renovations to 600 7th Street, 711 High Street, and 801 Grand Avenue with the goals of improving campus integration, increased focus on energy efficiency, and improving Principal's employee retention and recruitment abilities moving forward; and,

WHEREAS, the City Manager's Office has negotiated a conceptual assistance package of direct financial assistance and public improvement projects in consideration of Principal's undertakings and the tax base and employment opportunities it will provide, all as more fully described in the accompanying council communication; and,

WHEREAS, the undertakings by Principal are contingent upon the approval of additional assistance by the Iowa Economic Development Authority, and Principal has requested that the City sign Principal's Business Financial Assistance Application to the Authority, as the sponsoring entity.
