HOLD HEARING FOR THE VACATION AND CONVEYANCE OF THE EAST 12 FEET OF EAST 33RD STREET RIGHT OF WAY FROM VACATED THOMPSON AVENUE TO A POINT 282 FEET TO THE NORTH, TO ST. JOSEPH'S CHURCH OF DES MOINES, POLK COUNTY, IOWA FOR \$350

WHEREAS, on December 3, 2012, by Roll Call No. 12-1832, the City Council received a recommendation from the City Plan and Zoning Commission that the east 12 feet of East 33rd Street west of vacated Thompson Avenue to a point 282 feet north of said vacated Thompson Avenue, hereinafter more fully described, be vacated; and

WHEREAS, St. Joseph's Church of Des Moines, Polk County, Iowa, is the owner of the real property abutting such right-of-way, and has offered to the City of Des Moines the purchase price of \$350.00 for the vacation and purchase of the fee simple interest in such excess right-of-way as legally described below, for expansion and construction of a parking lot, which purchase price reflects the fair market value of the property as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said excess right-of-way; and

WHEREAS, on February 11, 2013, by Roll Call No. 13-0205, it was duly resolved by the City Council that the proposed vacation and conveyance of such excess right-of-way be set down for hearing on February 25, 2013, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public right-of-way, as described below, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of the east 12 feet of East 33rd Street from vacated Thompson Avenue to a point 282 feet to the north, more specifically described as follows:

THE EAST 12 FEET OF EAST 33RD STREET RIGHT OF WAY LYING WEST OF AND ADJOINING VACATED THOMPSON AVENUE AND LYING WEST OF AND ADJOINING LOTS 1074-1077 IN FOUR MILE, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, CONTAINING APROXIMATELY 3855 SQUARE FEET.

3. That the sale and conveyance of such right-of-way, as vacated and as described below, to St. Joseph's Church of Des Moines, Polk County, Iowa for \$350.00, subject to retention by the City of a permanent easement for existing utilities and a permanent easement for public ingress and egress over a portion of the vacated right-of-way, be and is hereby approved:
