RESOLUTION APPROVING SECOND AMENDMENT TO URBAN RENEWAL DEVELOPMENT AGREEMENT WITH LIBERTY BUILDING DEVELOPMENT GROUP, L.L.C.

WHEREAS, on April 12, 2010, by Roll Call No. 10-558, the City Council of the City of Des Moines approved a First Amendment to the Urban Renewal Development Agreement ("Development Agreement") with Liberty Building Development Group, L.L.C. ("Liberty") wherein Liberty undertook hotel renovation improvements within the Liberty Building located at 418 Sixth Avenue and the City agreed to pay an Additional Economic Development Grant for such hotel renovation improvements; and

WHEREAS, Liberty has applied for and is receiving urban revitalization tax abatement for the actual assessed value added by the hotel renovation improvements to the Liberty Building and in recognition of the receipt of such tax abatement by Liberty a commensurate reduction must be made to the Additional Economic Development Grant to be paid by the City; and

WHEREAS, a Second Amendment to the Development Agreement has been prepared to permit urban revitalization tax abatement on the actual value added by the hotel renovation improvements and to make the commensurate reduction to the Additional Economic Development Grant.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Second Amendment to the Urban Renewal Development Agreement between the City and Liberty Building Development Group, L.L.C., with such minor modifications as may be approved by the Legal Department, is hereby approved and the Mayor is hereby authorized and directed to sign the Second Amendment on behalf of the City of Des Moines and the City Clerk is authorized and directed to attest to the Mayor's signature.
