APPROVING SUBORDINATION AGREEMENT WITH RE PROPERTIES 1, LLC TO ALLOW BUILDING AT 424 EAST LOCUST STREET TO BE PLACED INTO A HORIZONTAL REGIME

WHEREAS, RE Properties 1, LLC (Tim Rypma, Member, 512-1/2 East Locust, Des Moines) purchased and renovated the commercial building at 424 East Locust Street and located in the Historic East Village. The developer improved the property with historical façade, structural and internal renovations. The developer's purchased the property for \$300,000, and invested renovation costs of around \$740,000 for a total project cost of \$1,040,000; and

WHEREAS, on October 24, 2011, by Roll Call No. 11-1794, the City Council duly resolved to approve a Neighborhood Commercial Revitalization Program \$15,000 Façade Grant, a \$5,000 Predevelopment Grant, and a \$135,000 Economic Development Bridge Loan for renovations to 424 East Locust Street; and

WHEREAS, a horizontal regime, one tax parcel for the ground floor commercial/retail space with the second tax parcel for second floor residential space, was part of the original project scope approved by Roll Call No. 11-1794. However, the horizontal regime was not put in place when the property was purchased and renovation begun; and

WHEREAS, the bank has requested approval of a subordination agreement that would allow for the declaration of a horizontal regime to have priority over the bank's first mortgage and the City's second mortgage but does not affect the security position of the two mortgages.
