## RESOLUTION APPROVING AMENDED AND SUBSTITUTED 28E AGREEMENT WITH THE BOARD OF WATER WORKS TRUSTEES REGARDING AN ONGOING COOPERATIVE UNDERTAKING TO ACQUIRE, PREPARE AND CONVEY LAND FOR REDEVELOPMENT IN THE DES MOINES AGRIBUSINESS PARK

WHEREAS, on December 6, 1999, by Roll Call No. 99-3719, the City Council approved a 28E Agreement with the Board of Water Works Trustees of the City of Des Moines, Iowa (hereinafter referred to as "Water Works") whereby Water Works agreed to provide one-third of the purchase price of approximately \$1.8 million, for the City to purchase 166 acres of land from the Archer Daniels Midland Company at SE 43<sup>rd</sup> and Vandalia Road in the SE Agribusiness Urban Renewal Area; and,

WHEREAS, the City and Water Works further agreed that any sale of such land would be subject to approval by the Des Moines Water Works; that the land would be used to accommodate the development of the Des Moines AgriBusiness Park for creating and sustaining value-added agricultural enterprises such as manufacturing and research and development facilities, related support services and other agribusiness functions; and that the City would actively pursue the marketing and development of the Property to achieve these goals, and to promote the sale of the land to large water and sewer customers, tax base generators and other users that satisfy the City's and Water Works' mutual interests; and,

WHEREAS, on February 25, 2013, by Roll Call No. 13-0344, the City Council conditionally approved the sale of 30 acres of such land to Helena Industries, Inc., subject to approval of such sale by Water Works; and,

WHEREAS, the proposed sale to Helena Industries, Inc., has provided an opportunity for the City and Water Works to reexamine the 28E Agreement and to adjust the Agreement to reflect the events and changes that have occurred since the Agreement was executed more than 13 years ago; and,

WHEREAS, the City Manager has negotiated an Amended and Substituted 28E Agreement between the City and Water Works to adapt the Agreement to the current circumstances, all as more specifically described in the accompanying Council Communication.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The Amended and Substituted 28E Agreement between the City and the Board of Water Works Trustees of the City of Des Moines, Iowa, is hereby approved, subject to such minor changes as may be approved by the City Manager and the City Legal Department.
