APPOINTING THE MAYOR AS THE CITY'S REPRESENTATIVE TO THE WARREN COUNTY EMERGENCY MANAGEMENT COMMISSION AND APPROVING THE MEMBERS OF THE CITY COUNCIL AND THE FIRE CHIEF AS THE CITY'S ALTERNATE REPRESENTATIVES TO SUCH COMMISSION

WHEREAS, pursuant to Iowa Code 29C.9 there is established in each county an emergency management commission to provide direction for delivery of the emergency management services of planning, administration, coordination, training and support for local governments; and

WHEREAS, pursuant to Iowa Code 29C.9, the Warren County Emergency Management Commission ("Commission") does exist and operates, being composed of representatives of the following governmental entities: the communities of Ackworth, Bevington, Carlisle, Cumming, Des Moines, Hartford, Indianola, Lacona, Martensdale, Milo, New Virginia, Norwalk, Sandyville, Spring Hill, St. Mary's, and West Des Moines, and County of Warren and the Warren County Sheriff; and

WHEREAS, a recent amendment to Iowa Code 29C.9 requires that only those Commission members who are elected officials may participate in activity relating to the Commission's budget under Iowa Code Chapters 24 and 29C.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Mayor is hereby appointed as the City's representative to the Warren County Emergency Management Commission and the Members of the City Council and the Fire Chief are hereby appointed as the City's alternate representatives to such Commission.

BE IT FURTHER RESOLVED that the City Council hereby affirms that the Fire Chief is authorized to act as signatory on behalf of the City on matters relating to the Commission By-Laws, and to act as the City's representative on Commission committees.
