## APPROVAL OF EXCEPTION TO PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS AND APPROVE STATE OF IOWA CONTRACT PROCUREMENT OF MICROSOFT SOFTWARE PRODUCTS AND SERVICES FROM INSIGHT PUBLIC SECTOR

WHEREAS, the Information Technology Department requested the Finance Department Procurement Division to renew the Microsoft Enterprise Agreement for various software products and services; and

WHEREAS, Microsoft software products and services have been competitively bid and are available from Insight Public Sector, 6820 S Harl Ave., Tempe, AZ 85283, Kenneth Lamneck, President and CEO, per State of Iowa Contract 4276-12; and

WHEREAS, Municipal Code section 2-725( c ) provides for the purchase of goods or services from contracts established by the State of Iowa Department of General Services or Department of Transportation, pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Purchasing Division; and

WHEREAS, Insight Public Sector and Information Technology Department staff have negotiated a threeyear agreement for specified products and services at a total cost of \$859,753.92, a copy of which is on file in the City Clerk's office; and

WHEREAS, \$175,443.52 of the first year funding is available from IFT010300/Enterprise Applications Development, and \$111,141.12 of the first year funding is available from IFT990000/MSC001, Capital Improvement Projects/Enhanced City-Wide Information System.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa that the above described State of Iowa contract procurement for the three-year renewal of the Microsoft Enterprise Agreement for various software products and services is hereby approved and the mayor is directed and authorized to execute said agreement with Insight Public Sector and implementing Microsoft licensing agreements on behalf of the City of Des Moines and the City Clerk is directed to attest to his signature.
