ORDERING CONSTRUCTION OF
2013 CITY-WIDE PCC PAVEMENT RESTORATION PROGRAM
AND FIXING A DATE FOR RECEIVING OF BIDS ON JUNE 11, 2013
AND PUBLIC HEARING ON JUNE 24, 2013
ENGINEER'S ESTIMATE IS \$330,500.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2013 City-wide PCC Pavement Restoration Program, 06-2013-003

The improvement includes furnishing, placing, curing, sawing, and sealing PCC pavement patches of various thickness in a cooperative effort with the City of Des Moines Public Works Department at the following locations in Des Moines, Iowa:

- 48th Street from Bel Aire Road to Crestmoor Drive
- Payne Road from M. L. King Jr. Parkway to 2327 Payne Road
- Washington Avenue from 2nd Avenue to dead-end east of Vermont Avenue
- E. 17th Court from Walker Street to E. University Avenue
- E. Washington Avenue from E. 16th Street to Dixon Street
- Glenwood Drive from S.W. 23rd Street to dead-end west of Virginia Place
- Willowmere Drive from Fleur Drive to cul-de-sac east of Park Plaza Drive
- Broad Street from S.E. 8th Street to S.E. 10th Street
- Indianola Avenue from Bloomfield Road to U.S. 69
- Williams Street from Maple Street to E. University Avenue
- E. Court Avenue from E. 4th Street to E. 4th Street
- S.E. 7th Street from Maury Street to dead-end south of Vale Street
- S.E. 9th Street from Maury Street to Shaw Street
- S.E. 10th Street from Maury Street to 200 feet south of Maury Street
- E. 17th Court from Garfield Avenue to Cleveland Avenue
- McCormick Street from Cleveland Avenue to E. Washington Avenue
- Wayne Street from Easton Boulevard to E. Washington Avenue
- E. 16th Street from E. University Avenue to Cleveland Avenue

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$330,500.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

Ray Drive, Des Moines, Iowa, at 11:00 a.m. on June 11, 2013, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its next meeting for action thereon.

BE IT FURTHER RESOLVED: That an appropriate Notice to Bidders and Notice of Public Hearing for said improvement be published in the Des Moines Register as provided and directed by Chapter 26 and/or 314, Code of Iowa.
