## RESOLUTION REDEDICATING A PORTION OF THE EAST/WEST ALLEY EXTENDING EAST FROM EAST 4<sup>TH</sup> STREET BETWEEN EAST GRAND AVENUE AND EAST LOCUST STREET FOR RIGHT-OF-WAY PURPOSES

WHEREAS, on June 23, 2003, by Roll Call No. 03-1516, the City Council held a public hearing at which it approved the vacation and conveyance of a portion of the east/west alley right-of-way extending east from East 4<sup>th</sup> Street between East Grand Avenue and East Locust Street ("City Right-of-Way") to SOHO Development, L.L.C. for \$31,200 for the purpose of incorporation into and redevelopment of the Betts Hardware Store site at 412 E. Locust Street, which site was also being purchased by SOHO Development L.L.C.; and

**WHEREAS**, on June 23, 2003, by Roll Call No. 03-1519, the City Council passed Ordinance No. 14,249, vacating the City Right-of-Way; and

WHEREAS, pursuant to the approved sale and the Offer to Purchase related thereto, closing on the sale of the City Right-of-Way to SOHO Development L.L.C. was to occur no later than December 30, 2003; and

WHEREAS, the SOHO Lofts project was completed without using the City Right-of-Way and thus SOHO Development, L.L.C. did not close on the acquisition of the City Right-of-Way, and said Right-of-Way continues to be owned by the City and used by the public and adjoining properties for vehicular and pedestrian access; and

WHEREAS, the City Right-of-Way requires rededication as public right-of-way for continued use as a public alley.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The east/west alley right-of-way extending east from East 4<sup>th</sup> Street between East Grand Avenue and East Locust Street, legally described as follows, is hereby rededicated as public right-of-way:

ALL THE EAST/WEST ALLEY RIGHT-OF-WAY LYING NORTH OF AND ADJOINING THE EAST 2/3 OF LOT 9, AND LYING NORTH OF AND ADJOINING THE WEST 1/3 OF LOT 12, IN BLOCK 9, EAST FORT DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

2. The City Clerk is hereby authorized and directed to forward a certified copy of this resolution to the Real Estate Division.
