ACCEPTING PROPOSAL OF APPLIED ECOLOGICAL SERVICES FOR THE PROVISION OF PROFESSIONAL CONSULTING SERVICES FOR THE ASSESSMENT AND MASTER PLANNING FOR STORM WATER MANAGEMENT AT WAVELAND GOLF COURSE AND GLENDALE CEMETERY AND APPROVING AGREEMENT FOR SAME

WHEREAS, the Departments of Park and Recreation, Public Works and Engineering desire to update the aging storm water infrastructure at Waveland Golf Course and Glendale Cemetery with ecologically based green storm water infrastructure improvements, requiring an assessment and master plan process; and

WHEREAS, on November 19, 2012, the Procurement Division solicited proposals for planning services for the Assessment and Master Planning for Storm Water Management at Waveland Golf Course and Glendale Cemetery by issuing Request for Proposal (V13-046), which was mailed to 11 potential proposers with 5 proposals received; and

WHEREAS, the Evaluation and Selection Committee has reviewed the proposals and has recommended that a contract for the provision of such consulting services be awarded to Applied Ecological Services, Inc., 21938 Mushtown Road, Prior Lake, MN 55372 ("AES"), for the sum of \$178,700.00; and

WHEREAS, an Agreement for Professional Services with AES has been negotiated by City staff and signed by AES, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the proposal submitted by Applied Ecological Services, Inc. is hereby accepted, and the Mayor is hereby authorized to execute the Agreement for Professional Services with Applied Ecological Services, Inc., a copy of which is on file in the City Clerk's Office, for the provision of the above described services in an amount not to exceed \$178,700.00, on behalf of the City, and the City Clerk is directed to attest to his signature.
