## APPROVING AMENDMENT TO AGREEMENT WITH CENTRAL IOWA HOSPITAL CORPORATION d/b/a UNITYPOINT HEALTH FOR WELLNESS SERVICES

WHEREAS, on October 23, 2011 by Roll Call 11-1810, the Des Moines City Council approved an agreement with Central Iowa Hospital Corporation ("CIHC"), then doing business as Iowa Methodist Occupational Medicine and now known as UnityPoint Health, Eric Crowell, President and CEO, 1200 Pleasant Street, Des Moines, Iowa 50309 to provide occupational health services for a period up to three years ending October 31, 2014; and

WHEREAS, certain employees are eligible to participate in a wellness incentive program which will require the administration of a health risk assessment; and

WHEREAS, the City of Des Moines received competitive bids for these wellness services and CIHC/UnityPoint Health submitted the lowest bid as described in the attached Council Communication; and

WHEREAS, the agreement between the City and CIHC may be amended by agreement of the parties; and

WHEREAS, approval of the amendment that has been prepared to include the aforementioned wellness incentive services is recommended.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

That Central Iowa Hospital Corporation, Eric Crowell, President and CEO, 1200 Pleasant St., Des Moines, Iowa 50309, is selected to provide wellness services and the Mayor is authorized and directed to execute the amendment on behalf of the City of Des Moines.


