SET HEARING FOR VACATION AND CONVEYANCE OF A PORTION OF THE NORTH/SOUTH AND EAST/WEST ALLEY RIGHT-OF-WAY ADJOINING 501 GRAND AVENUE TO POLK COUNTY FOR \$1

WHEREAS, Polk County, Iowa ("Polk County") is the owner of the real property locally known as 501 Grand Avenue, formerly used as the Polk County Convention Center; and

WHEREAS, Polk County has requested the vacation of the north/south and east/west alley right-of-way adjoining 501 Grand Avenue, and requested that the City convey said right-of-way in fee simple to Polk County in accordance with Iowa Code Section 364.7(3) for the public purposes of property assemblage for public health and welfare, redevelopment, and use as consideration for property acquisition for County Courthouse operations; and

WHEREAS, the City alley right-of-way proposed to be vacated and conveyed has been determined by the City Engineer and City Traffic Engineer to have no significant impact on public access, and the City will not be inconvenienced by the vacation and sale of said alley right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a portion of the north/south and east/west alley right-of-way adjoining 501 Grand Avenue, more specifically described as follows:

ALL THAT PART OF THE NORTH/SOUTH ALLEY RIGHT-OF-WAY LYING SOUTH OF EASTERLY EXTENSION OF THE NORTH LINE OF LOT 3 IN C.H. ATKIN'S SUBDIVISION OF LOT 13 IN THE OFFICIAL PLAT OF BLOCK I, GRIMMEL'S ADDITION, AND LYING NORTH OF THE EASTERLY EXTENSION OF THE SOUTH LINE OF THE NORTH 9 FEET OF LOT 1, ALHAMBRA NO.2, AN OFFICIAL PLAT;
