WHEREAS, the public gains and benefits generated from this economic development activity are warranted in comparison to the amount of funds invested in the economic development activity; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa that the City Manager is authorized to submit an application to the Iowa Economic Development Authority on behalf of Helena Industries, Inc.
