# HOLD HEARING FOR VACATION OF THREE SEGMENTS OF STREET RIGHT-OF-WAY FOR RAILROAD CROSSING CLOSURES AT THE HULL AVENUE, SCOTT AVENUE AND SE 34<sup>TH</sup> STREET CROSSINGS

WHEREAS, Union Pacific Railroad has requested vacation of the following City-owned right-of-way for permanent railroad crossing closures to address train and automobile movement constraints and to create rail capacity to support the growth of existing and new rail development business in Des Moines: Hull Avenue (also known as East Hull Avenue) between Delaware Avenue and Dixon Street; Scott Avenue between Southeast 20<sup>th</sup> Street and Southeast 22<sup>nd</sup> Street; and Southeast 34<sup>th</sup> Street between Scott Avenue and East Court Avenue; and

WHEREAS, on January 28, 2013, by Roll Call No. 13-0166, the City Council of the City of Des Moines received and filed a report and recommendation from the City Plan and Zoning Commission regarding the proposal by the Union Pacific Railroad to close the three street crossings identified above; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and the City will not be inconvenienced by the vacation of said right-of-way, subject to approval of the terms of agreement being negotiated between the City and Union Pacific Railroad regarding the construction of a series of infrastructure, crossing notification and buffering improvements to offset the impacts of the crossing closures; and

WHEREAS, on April 8, 2013, by Roll Call No. 13-0579, it was duly resolved by the City Council that the proposed vacation of such right-of-way be set down for hearing on June 10, 2013, at 5:00 p.m., in the Council Chamber; and

WHEREAS, thereafter it was determined that a scrivener's error existed in the legal description of the Hull Avenue right-of-way as included in Roll Call No. 13-0579, which error was corrected in the publication of notice of this hearing and is corrected as set forth herein below; and

WHEREAS, due notice of said proposal to vacate public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the public hearing on the vacation of City-owned right-of-way located at Hull Avenue between Delaware Avenue and Dixon Street; Scott Avenue between Southeast 20<sup>th</sup> Street and Southeast 22<sup>nd</sup> Street; and Southeast 34<sup>th</sup> Street between Scott Avenue and East Court Avenue, all legally described as follows, is hereby closed, and that all comments and objections made during said hearing are hereby received and filed:
