RESOLUTION APPROVING THE GRAY'S LAKE NEIGHBORHOOD PLAN AND ADOPTING THE PLAN AS AN ELEMENT OF THE DES MOINES 2020 COMMUNITY CHARACTER PLAN

WHEREAS, on August 7, 2000, by Roll Call No. 00-3381, the City Council adopted the Des Moines 2020 Community Character Plan; and

WHEREAS, on November, 21, 2011, by Roll Call 11-1965, the City Council selected the Gray's Lake Neighborhood Association to go through the Neighborhood Revitalization Program; and

WHEREAS, the Community Development Department staff has worked with the Gray's Lake Neighborhood Association to develop and prepare the Gray's Lake Neighborhood Plan as attached in Exhibit "A"; and

WHEREAS, a meeting open to the general citizenship of the Gray's Lake Neighborhood was held on May 7, 2013, and said Gray's Lake Neighborhood Plan was approved by the Gray's Lake Neighborhood Association Board of Directors on May 31, 2013; and

WHEREAS, the Gray's Lake Neighborhood Plan was reviewed by the Neighborhood Revitalization Board on June 5, 2013, and the Board voted to recommend City Council approval of the plan; and

WHEREAS, the City Plan and Zoning Commission held a hearing on the Gray's Lake Neighborhood Plan at their June 6, 2013 meeting, and the Commission voted to recommend adoption of the Plan as an element of the Des Moines' 2020 Community Character Plan.

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa that the Gray's Lake Neighborhood Plan is hereby approved and adopted as an element of the Des Moines' 2020 Community Character Plan.
