## APPROVAL OF AMENDMENT TO MICROSOFT ENTERPRISE ENROLLMENT AGREEMENT AND LICENSING FOR MICROSOFT OFFICE 365 SOFTWARE PRODUCTS AND SERVICES FROM INSIGHT PUBLIC SECTOR

WHEREAS, on January 23, 2012, by Roll Call No.12-0097, the City Council approved an agreement with Tyler Technologies for the City's enterprise resource planning following an extensive Request For Proposals process; and

WHEREAS, Tyler Technologies uses the Microsoft platform for all application processing and there is no integration from Tyler with any other email or office software suite; and

WHEREAS, Microsoft software products and services, including Microsoft Office 365, have been competitively bid and are available from Insight Public Sector, 22721 E. Mission Ave., Liberty Lake, WA 99019, Kenneth Lamneck, President and CEO, per State of Iowa Contract CT2979; and

WHEREAS, on April 22, 2013, by Roll Call No. 13-0653, the City Council approved an agreement with Insight Public Sector, per State of Iowa Contract CT2979, for Microsoft software products and services for a 3 year agreement for products and services, which did not include Microsoft Office 365, at a total cost of \$859,753.92; and

WHEREAS, Microsoft has provided amendments to licensing and enrollment agreements for use of Microsoft Office 365, which includes the right to use the City of Des Moines name in promotional materials, copies of which are on file in the City Clerk's Office; and

WHEREAS, the annual cost of the Microsoft Office 365 software suite is \$120,951 for three years; and

WHEREAS, funding is available from IFT010300, Enterprise Application.
