**Set Public Hearing for Proposed Amendments to the Fourth Year (2013) Action Plan of the 2010-2014 U.S. Department of Housing and Urban Development (HUD) Consolidated Plan**

**WHEREAS**, on November 05, 2012, by Roll Call No. 12-1735, the City Council approved and submitted to the U.S. Department of Housing and Urban Development (HUD) the Fourth Year (2013) Action Plan of the 2010-2014 HUD Consolidated Plan, and

**WHEREAS**, on May 30, 2013 HUD published the final funding allocations for the 2013 Community Development Block Grant (CDBG) program, HOME Investment Partnerships (HOME) program, and the Emergency Solutions Grant (ESG) program, and

**WHEREAS**, at the July 3, 2013 meeting of the Neighborhood Revitalization Board (NRB), the Board approved a recommendation to amend the 2013 Action Plan to include three new activities under the Neighborhood Revitalization Program, and

**WHEREAS**, federal regulations (24CFR91.505 (c)(2) and 91.105 (c) require that the City follow public notice procedures to provide citizens with reasonable notice and opportunity to comment on substantial amendments to the Plans for a period of not less than 30 days before the amendments are adopted, and

**WHEREAS**, the Council will conduct a public hearing during its regular meeting on August 26, 2013 at 5:00 P.M. and will publish a public notice of the same, which notice is on file with the City Clerk as EXHIBIT A and by this reference made a part hereof, in order to provide citizens with the opportunity to comment on the proposed amendments (EXHIBIT B) to the 2013 Action Plan and participate in the hearing.
